Introduction

Thank you for visiting the Allianz Global Corporate & Specialty website and reviewing our Privacy and Security Statement.

Allianz Global Corporate & Specialty is part of the Allianz family of companies. In North America, Allianz Global Risks US Insurance Company and AGCS Marine Insurance Company comprise the dedicated North American carriers for Allianz Global Corporate & Specialty.

Although Allianz Global Corporate & Specialty products are not intended for personal, family or household use, our pledge to protect your privacy is reflected in this Privacy Statement which outlines our principles in collecting, using and safeguarding your personal information and information about your relationship with us.

Depending on your state of residence, state law may provide additional privacy protections. You can request a copy of our Privacy Statement outlining any state specific protections by writing to the address below.

Allianz Global Corporate & Specialty does not share or sell your personal information for marketing purposes. For this reason, no “opt-in” or “opt-out” is required.

Personal Information Allianz Global Corporate & Specialty Collects

Allianz Global Corporate & Specialty only collects personal information about you when it is necessary to conduct the business of insurance. We limit the collection of personal information to what we reasonably believe is needed to administer your account. As a result, we collect personal information from the following sources:

- Personal information you share with us either directly or through your agent or broker, such as the information on your insurance application, requested policy change information or other forms you may complete.
- Personal information you provide or which is obtained through the process of handling a claim, including medical information, such as from an accident report.
- Personal information about you from your transactions with us, our affiliates or others such as the number of years you have been a policyholder with Allianz Global Corporate & Specialty or the types of coverage you purchase.
- Personal information about you from a consumer reporting agency, such as a credit report or a Motor Vehicle Report.
- Any personally identifiable information submitted to Allianz Global Corporate & Specialty in connection with an e-commerce transaction or a resume/CV is used strictly for the purpose of completing such transaction or evaluation of qualifications, respectively, and is not shared with third parties.

If you visit or use the Allianz Global Corporate & Specialty Web site, or one of our subsidiaries, we may use "cookies" (small text files transferred from our website to your hard drive) to recognize repeat users, track usage and facilitate your access to and use of the site. We do not use "cookies" to gather personal information and we do not link cookies to identifiable information, such as your policy number. The "cookies" only enable you to use our Web site more easily.

If you are a registered user with Esolutions, our online system for accessing information specific to your account, registration involves your email address. A user's email address is shared within Allianz Global Corporate & Specialty on a need-to-know basis only and is not shared with third-parties.

Personal Information Allianz Global Corporate & Specialty Discloses

Allianz Global Corporate & Specialty does not disclose any personal information about current or former customers to anyone, except as permitted by law. We may disclose the personal information we collect as follows:

- To consumer reporting agencies for the purposes of obtaining a credit report or a Motor Vehicle Report in order to determine eligibility for coverage or to process your requested transaction.
- To your insurance agent or broker to allow them to perform their normal insurance related services for you.
- To medical professionals in order to process your claim.
- To law enforcement or other government agency as required by law or to report suspected fraud activities.

When possible, we advise our vendors and other nonaffiliated third parties to whom we legally provide your personal information in the course of conducting our insurance business, of our privacy policy. We make every effort to use vendors whose approach to customer privacy reflects our own.

Allianz Global Corporate & Specialty Policies and Practices with Respect to Security of Personal Information

Allianz Global Corporate & Specialty uses a variety of computer hardware and software tools to maintain physical, electronic and procedural safeguards that comply with applicable federal and state regulations to guard your personal information. We restrict access to personal information about you to only those employees who need that information to provide products or services to you.

Allianz Global Corporate & Specialty, and its subsidiaries, also works hard to ensure that our websites are secure. We employ firewalls, encryption technology, user authentication systems and access control mechanisms to control access to the personal information that may be shared over these sites.
