Coverage Highlights

Additional Insured – Automatically provides insured status when required by written contract

Broadened Named Insured – Any new entities acquired or employees hired are immediately and automatically covered until your policy expires

Waiver of Subrogation – Provides an automatic waiver of rights of subrogation when required by a written contract

Customer Lease or Loan Physical Damage – In the event of a total loss, all covered vehicles are insured for actual cash value or outstanding indebtedness, whichever is greater

Rental Reimbursement or Additional Transportation – Up to \$1500 for 45 days with no imposed daily limit

Communication Equipment – Provides up to \$1500 per accident on permanently installed electronic equipment

Extended Glass – The deductible is waived when you have the glass repaired rather than replaced

Extended Towing – Covers up to \$750 in towing per disablement. If a truck type vehicle is disabled, a \$250 deductible applies

Tapes, Records, CDs and DVD – Covers up to \$250 for owned property inside auto at the time of loss

Personal Effects Coverage – Provides up to \$500 for loss to clothing items or other owned personal effects inside auto at the time of loss

Auto Medical Payments – Provides increased auto medical payments to \$5,000 if coverage is purchased, and triggered by the appropriate Covered Auto Symbol on the declarations

Hired Auto Physical Damage and Loss of Use Expenses – Extends coverage to hired autos in addi-

tion to covered owned autos. Hired auto loss of use expense provides limits of \$100 per day with a \$1000 maximum

Two or More Deductibles – For physical damage coverage, in the event that more than one Allianz coverage form applies to the same accident, then we will apply only one deductible to the accident

Additional coverage is provided for:

- Mental anguish when arising out of physical bodily injury
- Owned vehicles temporarily operated in Mexico
- Fellow employee coverage if employees are provided commercial autos by their employer and do not have their own personal auto insurance
- Unintentional failure to disclose hazards

FleetCover® also offers:

- Broadened definition of who is an insured to automatically extend insured status to employees
- Broadened coverage territory for hired auto covering losses and accidents anywhere in the world if

auto is leased, hired, rented or borrowed without a driver for 180 days or less

- A four-month notice of cancellation
- Increased limits for supplementary payments providing up to \$2,500 for the cost of bail bonds and up to \$500 in daily expenses
- More favorable reporting duties in the event of a claim or suit
- Inclusion of mechanical breakdown for the accidental discharge of an airbag
